

MinnesotaCare End of Year Changes for Certain Undocumented Individuals

Why is there a change?

- The 2025 Minnesota legislature amended state law to change MinnesotaCare eligibility for certain individuals who are undocumented.
 - MinnesotaCare is no longer available to new applicants who are 18 or older.
 - Undocumented individuals who are age 18 or older who were already enrolled in MinnesotaCare on June 15, 2025, may remain eligible for MinnesotaCare through December 31, 2025, as long as they continue to meet all other MinnesotaCare eligibility factors. For MinnesotaCare, an individual is considered age 18 the month following their 18th birthday.
 - Children under age 18 remain eligible if they meet all other eligibility requirements.

- Renewal batches/process
- Notice suppression
- Closing notices

Renewal batches

- The January MA/MCRE Renewal batches will continue as usual.
- Any person who is not lawfully present without an SSN will go Need To Renew, those under 18 with an SSN may auto renew (AR).

Renewal Forms and Closure Notices

- Renewal and auto close notice for households where all enrollees 18 or over:
 - Households that are all undocumented MinnesotaCare enrollees 18 and older will not receive a renewal form. Their eligibility will end 12/31/25.
- Households with enrollees under 18 and age 18 and older:
 - Households that have enrollees under 18 AND 18 and older will receive a renewal form, which has been updated to include a new section “Members who no longer qualify”. All undocumented household members who are age 18 will be listed in this new section.
- Closure notice:
 - DHS will send a closure notice to all undocumented enrollees who are age 18 and over to notify them that they will be closing 12/31/25.

Example of New Renewal Form Section

Members who no longer qualify

Due to a change in state law, the members listed no longer qualify for MinnesotaCare starting **January 1, 2026**. We will send these members a separate notice about their MinnesotaCare eligibility ending.

Report immigration status changes or pregnancy. You may qualify for another health care program. Contact the agency listed at the top left of this notice or speak with a navigator for assistance.

 - Eligibility will end in METS
 - Coverage will end in MMIS
 - Closure notice will be issued
